# **Print Training Australia Fees 2024**

## NATIONAL STUDENT FEES

In this document any reference to “Print Training Australia”, is a reference Humanagement Pty Ltd (A.B.N. 20 101 225 021) trading as “Print Training Australia” (TOID 40122).

All fees and charges in relation to the delivery of Print Training Australia’s standard training courses are contained in this booklet. The fees and charges listed include, but are not limited to, training and assessment, participant materials, participant support, and facilitator travel. If a variation from Print Training Australia’s standard price is required for compensation of additional services (such as course customisation) additional fees and charges will apply. Any additional fees and charges will be agreed to in writing, prior to the commencement of training, between Print Training Australia and the client.

Print Training Australia reserves the right to withhold certification until full payment is received (please refer to Print Training Australia’s Fee, Charges and Refunds Policy).

## FEE FOR SERVICE (FFS)

These fees are charged for participants not eligible for State Government funding.

All student tuition fees published are subject to change given individual circumstances at enrolment.

Print Training Australia’s standard instalment structure of fees is as follows:

**Commencement fee**, which is invoiced prior to commencement of training

**Progression payments**, which are interest free equal instalments (the number of which depends on the length of the program)

## ELIGIBILITY – STATE GOVERNMENT FUNDING

If a participant qualifies for State Government funding, the enrolment fee may vary according to requirements specific to each State. The availability of State Government funding and the participant’s ability for funding is also subject to requirements specific to each State.

Concession fees and fee waivers may be available for eligible participants and will be applied subject to the relevant State requirements.

All pricing is based on State funding conditions at the time of publication; should these conditions change, Spectra reserves the right to withdraw or amend an offer.

Eligibility for State Government funding is independent of eligibility for Commonwealth funding incentives paid to the employer.

Employers do not receive State Government funding; this funding is paid directly to Print training Australia for the provision of training services.

Concessions and partial or full fee exemptions may apply as per State Government regulations. Evidence demonstrating eligibility for such exemptions or concessions (eg. a Health Care card) or evidence of financial hardship for each individual participant will be required to access a reduced enrolment fee or for exemption for an enrolment fee.

## ELIGIBILITY – COMMONWEALTH FUNDING

Guidance on Commonwealth Government funding should be obtained from your Australian Apprenticeship Support Network (AASN) provider.
